
ORDERED ON 19 APRIL 2017

1. The applications for leave to appeal under Case Numbers 771/16 and 1170/16 are hereby consolidated and shall be adjudicated in a single hearing in terms of s 17(2)(d) of the Superior Courts Act 10 of 2013.
2. The parties must be prepared, to address the court on the merits if called upon to do so at such hearing.
3. The National Prosecuting Authority must, by 30 April 2017, file five additional copies of its application for leave to appeal and supplement the record filed by President JG Zuma.

4. The Applicants must file their heads of argument on or before 5 June 2017.
5. The Respondent must file its heads of argument on or before 3 July 2017.
6. Should the parties reach agreement on shorter periods than those referred to in paragraphs 3, 4 & 5 above, the court would be amenable to grant such shorter periods, to allow the matter to be enrolled in the third court term.
