**RESPONSE:**

Yes, the Department entered into a contract with Dinovert (Pty) Ltd t/a Cuvera which later changed their name to Mediosa. The contract was entered into in 2015/2016 financial year. No other contract was entered into with the company prior to this date. The contract is for the provisioning of the primary healthcare services using a mobile medical service unit (MMSU) for designated districts in the Free State.

- (a) The supplier is paid per patient and for services rendered. The contracted service package is as follows;

- 13.1 Whether an invitation to tender has been advertised for the supply of ambulance services in the Free State to replace the contract with Buthelezi Ambulance Services; if not, why not; if so, (a) on which dates, (b) in which publications and (c) what are the detailed specifications published;
- 13.2 How many bids for this tender has been received to date, (b) from which companies and (c) the value of each;
- 13.3 Whether a bid has been awarded; if so, (a) to which company and (b) what is the total contract value; if not, why not?

#### RESPONSE

Yes, a bid has been advertised for Ambulance Inter-facility Transfers services. The bid is for the same services that Buthelezi EMS is been contracted for. The Department required 37 additional ambulances in order to render the inter-facility transfers services. Regrettably, it has not been feasible to phase out the inter-facility transfers services rendered by private service providers all at once, due to higher demand and the implications thereof if the service was discontinued abruptly. The phasing out of the use of private ambulances is possible; however, it requires the Department to take over the service in phases. The Department therefore plans to procure 20 ambulances and appoint 5 crew members per ambulance in the new financial year (2018/2019). The remaining number of ambulances will be procured in the 2019/2020 financial year. Per norm, each ambulance requires 10 crew members and their appointment will also be done in phases.

As an interim measure and to allow the process for implementation of the plan to phase out the use of private ambulances for inter-facility transfers to be finalized, the Department advertised a bid, DOH (FS) 11/2017/2018, (a) on the 13 October 2017 with the closing date of 17 November 2017, (b) in the Tender Bulletin and e-Tender Portal, (c) the bid called for appointment of service provider to render inter-facility transfers for the Free State Department of Health with detailed specifications as provided in the bid document on the eTender Portal.

Seven (7) bids were received, (b) from the bidders indicated below, (c) bid is not yet awarded and values are not applicable

- S.L Medical Services (Pty) Ltd
- High Care EMS (Pty) Ltd
- Golden Care Ambulances Services
- Maponya 911 Rescue cc
- South Africa EMS Competency Academy t/a 1 Life 911
- Bosiphe Trading and Projects (Pty) Ltd, and
- Buthelezi Ambulances

The bid has not been awarded as yet, it is still at the evaluation stage. The department is intending to contract a private service provider of inter-facility transfers services for a period of two years with a reduced number of the ambulances. The final award should be informed by the proper, accurate and adequate information.

**RESPONSE**

As part of the specifications for the contract the following were requirements from the Department:

- Basic Ambulance Assistant assumes duties of a driver as part of the crew and practices under supervised practice with either an AEA or CCA.
- Minimum of 1 Advanced Life Support must be available per local area.
- All vehicles must have minimum of 1 Intermediate Life Support crew.

(aa) All staff must have current registration with Health Professions Council of South Africa and proof was submitted with the bids.

(bb) We have a total of 47 operational ambulances in the Province.

(cc) Each institution verifies operators qualifications during hand over and notates this information on each case patient report form. Furthermore with billing clinical managers or facilitators verifies treatment supplied as per request of services.

Compliance in line with the provision under the National Health Act (No 61 of 2003) was signed off for implementation on the 1<sup>st</sup> December 2017 and each ambulance service has been granted 12 months preparatory timeframe to ensure compliance to the regulations.

The department is currently finalising appointments of the Licensing and Inspection committee members so that as from 1<sup>st</sup> December 2018 all services must apply for licensing.
