REVELATIONS: BOSASA PAYMENTS

1. As you are aware, we represent the Democratic Alliance (DA).
2. Our client has taken note of the testimony of Mr Angelo Agrizzi, the former COO of Bosasa, that is currently underway at the State Capture Commission of enquiry.
3. It is patently clear that various government contracts have been awarded to Bosasa with various contracts so awarded, still in place. The awarding of these contracts is tainted with allegations of corruption, bribery and fraud.
4. Our client has instructed us to request an undertaking by you, as the Head of Government, to immediately take the following actions:
 - 4.1 You will immediately call for an independent audit on Bosasa's dealings and contracts held with government and State Owned Enterprises ("SOE") by instructing your Cabinet to audit their individual departments;
 - 4.2 You will immediately instruct all functionaries to investigate the legitimacy of the contracts and where necessary terminate the contracts and/or approach the Court to set the illegal contracts aside;
 - 4.3 You will direct the SAPS/Hawks to investigate the allegations with the necessary diligence and vigour;
 - 4.4 You will ensure that internal disciplinary action against all the ANC members implicated are taken forthwith.
