Sir,

The subject matter bears reference.

By now you would have already had sight of the report. I, however, attach a subjoined link to it for ease of reference. The portion I refer you to beings on page 551.

I am concerned that the SIU suggests that you are still reviewing matters in light of the clear findings that they have presented to you. The various timelines are presented in their report.

I am also concerned that you have not acted on the information provided to you. Or, that no evidence of this has been provided to the Education portfolio committee or the house to confirm that you have acted based on their findings presented to you.

You have mentioned on various occasions that you will ask the SIU to review their findings, which they confirm in this report. It is uncertain why, considering their concrete evidence suggesting maleficence, you persisted in trying to oppose them.

Your lack of response to their findings and even to the recent release of their findings is discourteous to their authority if not contemptible.
