REPORT OF FINANCIAL MISCONDUCT AGAINST THE MUNICIPAL MANAGER MR FRANS TEMEKI MABOKELA

The Provincial Treasury received the attached letter dated 24th July 2022 from Cllr. Thabiso Morebantwa citing allegations of acts of financial misconduct against the Municipal Manager, Mr France Temeki Mabokela. In his letter the alleged acts of financial misconduct are as follows:

Remuneration of the member of political office bearer who is no longer a public office bearer	Sec 167 (1) (a) of the MFMA	Irregular expenditure
Utilising MIG (Conditional Grant) for purposes unintended for	DORA 2022 Section 16 (1)	Failure to implement planned and budgeted Service delivery projects.

Contravening SCM Policy: Procuring unbudgeted vehicles and laptops	Section 1 of the MFMA	Unauthorised Expenditure

The above alleged act of financial misconducts are deemed serious and therefore requires the municipality to conduct investigations in line with Regulation 4 (1).

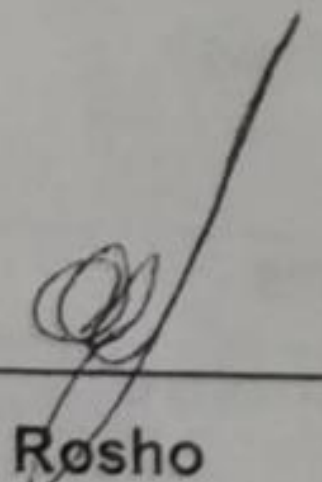
The municipality established the Disciplinary Board in October as required by Regulation 4 (1) of Municipal Regulations on Financial Misconduct and Criminal Proceedings, which expired in September 2020 as per Regulation 3 (4).

In light of the above you are therefore required to establish the Disciplinary Board and table the above allegations of financial misconduct in the next council sitting in line with Regulation 4 (1) and 3 (2).

You are further directed to investigate the above allegations of financial misconduct or financial offence within two (2) months of establishment and submit quarterly progress reports.
