Collection Vs Payment per ward – January 2023

Communities are receiving statements or Bills via emails and SMSs. This process is encouraged to all communities by the respective ward councillors and the Administration at the municipality. Clients are encouraged to provide their contact details so that when statements are sent, majority of them can access municipal bills and can be called for payment arrangements. Post office letters took a long time before they were delivered hence the municipality opted for this this viable alternative.

The prerogative to place the municipality under intervention lies with the Provincial Executive Council after having considered the assessment made by either Provincial Cogta or Treasury Department. Further than that all other measures must have failed and the only option left is for invocation of Section 139. The court had ruled in some of cases that section 139 intervention must not be used as a punitive measure but as a last resort. Therefore in order for section 139(7) to be invoked all the above factors must have been considered and that all other intervention must have failed to yield the desired results.

- 6. Do all applications include a comprehensive list of affected households? If not, why not?
- 7. Have communities where temporary structures have been erected been informed of the development of temporary relocation structures in their area? If not, why not? If so, what was the relevant process?
