In light of the fact that since 2019, a total number of 5 489 members of the SA Police Service (SAPS) have been arrested and charged with criminal offences, what (a) types of crimes were committed by the members, (b)(i) number of convictions were secured and (ii) for what specific crimes and (c)(i) total number of members out of the 5 489 members are still in the employ of the SAPS and (ii) what are the reasons?

- Operating a vehicle while under the influence of liquor/drugs.
- Party to employment relationship accepting/agreeing/offering to accept unauthorised benefit.
- · Perjury.
- Point any firearm.
- Possession/usage of a drugs/dagga.
- Prohibition in regards to the playing of games of chance.
- Prohibition an offer/acceptance of benefit.
- Public indecency.
- Rape.
- · Other offences under the Road Traffic Act.
- Reckless/negligent driving of a vehicle.
- Robbery with firearm.
- Sexual assault.
- · Shoplifting.
- · Stock Theft.
- Taking delivery of stock without obtaining documents.
- Tampers with, damages/destroys essential infrastructure.
- Theft general.
- Theft of motor vehicle/motor cycle.
- Trafficking in persons.
- · Use road vehicle without owner's consent.
- (c)(i) A total number of 3 981 out of the 5 489 members are still in the employment of the SAPS.
- (c)(ii) In terms of Regulation 5(3)(dd) of the SAPS Discipline Regulations, 2016, it is constitutes misconduct to be found guilty of a common law or statutory offence

by a court of law. In order to confirm whether disciplinary steps were taken against convicted members, as set out in the Regulations, it will require a physical inspection of both printed and electronic records, since 2019. The analysis of this information will identify the reasons why the members, who allegedly committed crimes, are still in the employment of the SAPS. The Honourable Member will be apprised of the reasons, once all the data has been gathered and thoroughly analysed.
