- Centlec was not paid by Department of Public Works and later the same Department reported that Centlec has been paid and instructed on a number of occasions to reconnect the electricity but to no avail.
- The Department made attempt to pay from its own budget but Public Works halted the process indicating that it is not our mandate to pay electricity for government buildings. The Head of Department also wrote a letter to his counterpart in the Department of Public Works to request him to assist in addressing this matter and the letter is dated 28 May 2024.
- The Department of Public Works is the one which can advise when the power will be reconnected in the Museum.
- The public does not have access to the museum.
- -The Museum is dark and by not allowing access we simply are securing safety of visitors and also there is nothing to see in the museum which is dark.
- -Access will be restored once the electricity is restored or alternative plans are put in place by Department of Public Works.
- 1. Yes, the report I got the access to the museum is secured, but I still have to visit the museum myself.
 - The Department does have day and night physical security personnel guarding the Museum.
 - b) I am told that there is an appointed private security company.

- It is reported that the museum is protected against fire, theft and vandalism through the services of the procured private security company .
- The report I received is that the last inventory was done at the museum in November 2023 and the next one will be conducted in November 2024.
