# NERSA CONFIRMS VENUES FOR PUBLIC HEARINGS ON ESKOM'S REVENUE APPLICATION FOR THE 2025/26, 2026/27 AND 2027/28 FINANCIAL YEARS

The National Energy Regulator of South Africa (NERSA) today confirmed the venues for the public hearings on Eskom's Sixth Multi-Year Price Determination (MYPD6) revenue application for the 2025/26, 2026/27 and 2027/28 financial years. The public hearings are scheduled to be held from 18 November to 4 December 2024 and will be conducted in the provinces of South Africa as indicated in Table 1 below.
