**QUESTION NO: 79**

**Mr N Gotsell (Western Cape: DA) to ask the Minister of Correctional Services:**

- (1) With reference to his reply to the National Assembly Question 2016 on 4 December 2024, with specific reference to the breakdown that has been provided in respect of the Western Cape, (a) what is the nature of smoking pipes that were discovered, (b) how many of these were glass 'tik pipes' and (c) what is the breakdown of the respective types of drugs like (i) tik, (ii) dagga and (iii) mandrax that were discovered;
- (2) in respect of the amount of approximately 548 866 58 grams of drugs that were discovered and/or confiscated over the 12 month period, (a) how many incarcerated persons that are (i) remand detainees and (ii) detainees who are respectively facing additional investigations and/or charges for (aa) possession of and/or (bb) dealing in drugs in respect of the Criminal Procedure Act, 1977 (Act No. 51 of 1977), and (b) what is the (i) reference number, (ii) detainee name and surname and (iii) status of each of the cases that are referred to;
- (3) (a) how many internal investigations have been opened against Correctional Services employees and/or officials for aiding and/or assisting in soliciting drugs and/or drug paraphernalia and (b) what is the (i) reference number, (ii) employee name and surname and (iii) status of each of the cases that are referred to?

**REPLY:**

- (1)(a) The confiscated smoking pipes are made of glass and are also known as lollies because they resemble the shape of a lollypop sweet.
- (1)(b) All fourteen (14) smoking pipes found were glass 'tik pipes'.
- (1)(c) The breakdown of respective types of drugs is as follows:

(i) Tik	(ii) Dagga	(iii) Mandrax

(2)(a) The total number of incarcerated persons who are:

- (i) Remand Detainees are 95 in total.
- (ii) Detainees facing additional investigation and/ or charges are 28 in total.
