RESPONSE TO LEGISLATURE QUESTION 5. INF068. POSED BY MEMBER M WATERS OF THE DEMOCRATIC ALLIANCE (DA)

- **5. INF068.** With regard to reply to question 5.ED215 of 2025 (attached):
- (i) What are the minimum standards with regards to how often a school ought to be inspected by engineers to ensure that the structure of the school is sound and safe;

Response:

According to the Government Immovable Asset Management Act (GIAMA), (Act No. 1 9 of 2007), the Custodian of the immovable assets has the responsibility of assessing the condition of the immovable asset at least every fifth year. In the Gauteng, the Custodian is the Gauteng Department of Infrastructure Development (GDID) and the User of educational assets is the Gauteng Department of Education (GDE).

(ii) What is the legislation surrounding inspection by engineers;

(iii) Please provide a list of all public schools and the last date each school was inspected by engineers;

Response:

The Department of Infrastructure Development (DID) has, over the preceding years, undertaken comprehensive conditions assessments of the forty-eight (48) schools enumerated herein. The assessment reports have been duly submitted to the Gauteng Department of Education (GDE) to facilitate the execution of the prescribed recommendations.

In alignment with the mandate vested in the budget holder, DID, in collaboration with GDE, actively implements the restorative repairs programme. This programme encompasses the systematic identification of facilities necessitating intervention.

Moreover, through a consultative process engaging an extensive array of school stakeholders, GDE has identified fifty-seven (57) schools requiring structural intervention. Below projects were addressed as a special programme to address varied defects from an urgent intervention perspective. However, some evolved to bigger project and taking longer time based on their complexity.
